Research experience

- Preparation of a successful funding application and research protocol for a preliminary study to begin to identify factors preventing the recognition of dementia. Research Question: "Why do patients who have dementia arrive at the general hospital (Great Western Hospital) without any previous contact with the dementia service?" Qualitative research using semi-structured interviews to be analysed using interpretative phenomenological analysis (IPA).
- 3½ years spent in a research environment (dementia and memory problems), working closely with both academic researchers and a clinical trials team.
